

Dr. Robert E. Hayes, Jr. serves as Bishop Emeritus in the Global Methodist Church.

The Global Methodist Church's Transitional Leadership Council (TLC) recently received the Rev. Dr. Robert Hayes, Jr. as a clergy member in the new denomination and then immediately voted to confer upon him the title bishop emeritus.

Hayes also serves as Bishop-in-Residence at The Woodlands Methodist Church, taking a regular preaching rotation in the 8:30 a.m. and 11:00 a.m. Traditional worship services at TWMC. He is also involved in the church community and serves as chaplain to the church's staff.

As someone who comes from a family of ministers and has had his own 40-plus years of ministry, Bishop Hayes is uniquely equipped to advise TWMC's pastors. He witnessed first-hand as the UMC experienced radical changes, from its formation in 1968 and the struggle to integrate black and white churches all the way to how technology has changed the worship experience itself.

"I'm privileged to have spent a generation or two of seeing ministry, and I marvel now because when people show up, they don't carry a Bible," he says. "They open up their iPad, bring their iPhone and read the scripture on the screen." Through all of this evolution, there is one key element that he says has stayed the same and that he would want to emphasize to every minister: "At the end of the day, I don't care how much technology you have," he says. "It's still going to come down to being relational. It's about people, it's about knowing that you and I are human beings and we are made in the image of God and we need to identify with each other. We need to love one another."

Bishop Hayes is married to Delilah (Dee) and has three adult children — Joya, Robert III and Ryan — and two grandchildren.

WORKSHOP #3 | Gym This is My Story, This is My Song: Telling Your Personal Story

Just as in Scripture, Methodism has a long historical tradition of telling our stories, or testimonies. In this workshop we will consider how to share our stories from a Christ-centric perspective. What does remembering look like beyond, "such and such happened?" How do we remember our own personal journey while giving attention to God's Presence and His work? How can we practically and clearly tell our story (written or verbal) in ways that others may also experience God amongst us?

Who is transferring credentials from another TCAT or PAC? The PAC stands for the Provisional Annual Conference. Every Annual Conference is a Provisional Annual Conference until the Convening General Conference. So, we would recognize that coming to us is Tommy Stringer. Book of Discipline, the TBDD, simply says that's a moment of recognition as the Board of Ministry handles transfers between, but there's no official Conference action. Now, this one in Paragraph 416 that is in your report is a simple majority vote. It is who is transferring clergy credentials from non-United Methodist Church denominations. But persons who come from a denomination other than United Methodist, who join with us, are James Blankenship, comes from another non-UMC tradition. Earl Griffin, Earl Griffin, Sr. from the CME and Sangho Lee from the Korean Methodist Church. This would require, Bishop, a simple vote of the Clergy Session, to accept these three (3) persons.

Bishop Jones:

If you will approve their becoming a part of this Conference, would you say "yes". Any opposed? "NO". And it's done.

Burt Palmer:

Thank you, Bishop. I will not read all of the names, because they're in the Pre-Conference Report. What I'm going to do is recognize that we have transferring clergy credentials from the United Methodist Church under Paragraph 419, which is to be recognized. Eric Rasmussen. Senior Deacon – Donna R. Alberts and Margaret Bellows. A great group of Elders. I'm not gonna read all those but we need to make the following additions and edits. In your B categories, last names Bs – Jeremy Bass who is serving at First Bryan would be added to that category. On the far-right hand column, you would add Stephen, is it Yeich? And he would be moved up so in the Pre-Conference Report he is listed as a Senior Elder, but he is an Elder. There is no change in the list of Senior Elders. There are no Valid Deacons and there are no Valid Elders. So, Bishop, at this moment, that's a simple moment of recognition.

Bishop Jones:

All these people are so recognized. The next part of our report is those individuals who are going to be ordained Deacon, Deacon and Elders, and Elders within our Conference. Each of these requires a 2/3 vote according to the TBDD. The names have been submitted to you already, are in your Conference Report. There will be one name – Laurie Anne Tuttle – will insert Anne, her middle name so that will be added but that is the group that you have in your Journal.

From your Pre-Conference Report, these adjustments to those persons who are going to be ordained Deacon and Elder. So, these adjustments to your Pre-Conference Report these will be reflected in what you receive afterwards. First, you would strike the name Kathyrn Burchfield, not because we have any problem but is already Ordained a Deacon in February. You'd strike the name Casey Estler who is not able to attend ordination this year. You'd strike the name Gerald Stephen Powley who is unable to attend the ordination service this year. Under the name James Jimmie Snow you would simply strike the name James. Jimmie, it's Jimmie Snow, that is her name. Underneath the name, the last name in that column, it says George R. Wright. It's actually Douglas, so it would be Douglas R. Wright.

Persons who will be ordained Elders at our Conference this year. Respectively, we move through Paragraph 409, 409, 410 and back to 410. Verronda Flanagan, Deneen Goldsmith, Ellen Kent, Vivian Kinnear, Russell Martin, Christopher McLain, Randall Morris (who in your Pre-Conference Journal was listed Deacon and Elder but had been previously ordained a Deacon inFebruary of '23, will be ordained Elder), and then Charles McAllister Vaughn.

Burt Palmer:

Bishop, on behalf of the Board of Ministry, those we've prayed over, those persons to be ordained Deacon, Deacon and Elder, and Elder – I would turn it back to you for a call of the vote.

Bishop Jones:

If you will approve the ordinations of the three (3) categories that you just heard, Deacons, Deacons and Elders, and Elders – would you lift a hand? Down. If you're opposed, lift the hand. Let it be shown in the Minutes that it was a unanimous vote, which exceeds the two-thirds

GUIDELINES For Our Life Together As a Conference July 6, 2023

Following the biblical admonition in Hebrews 12:15 and elsewhere, John Wesley early on encouraged his followers to "watch over one another in love." As the heirs of that tradition, our goal is still to peacefully work together for the common good of all in fulfilling the mission of the church. Within the annual conference, thus, these guidelines are established to spell out how we can best go about our mission while still caring for all and making a bold witness for Christ to the world.

SECTION ONE: ESTABLISHMENT OF THE CONFERENCE

- 1. The Eastern Texas Conference (hereafter referred to as the "Conference") is established and operates under the authority of ¶610 of the *Transitional Book* of Doctrines and Discipline of the Global Methodist Church (2022). It likewise functions as an incorporated organization recognized by the State of Texas and as a part of the global denomination governed by the *Transitional Book* of Doctrines and Discipline of the Global Methodist Church (2022).
- 2. The structures and organization of the Conference shall be determined In alignment with those of the denomination as a whole. Any discrepancy between the structure and procedures of the Conference and the Transitional Book of Doctrines and Discipline shall be resolved in favor of the denominational provisions outlined in that book.
- 3. The boundaries of the Conference shall be established by the Connectional Council of the Conference in conjunction with the Transitional Leadership Council of the Global Methodist Church. Initially, the Conference shall roughly be composed of congregations within the eastern third of Texas, plus churches in Louisiana, Arkansas and other parts of the region who wish to affiliate with the Conference on a transitional or permanent basis.

SECTION TWO: PROCEDURES OF THE ANNUAL CONFERENCE

- 1. The Eastern Texas Conference shall meet at such a time and place as determined by the President Pro Tempore and with the presiding Bishop. The Conference shall meet on at least an annual basis for a time of worship, education, inspiration, and conducting necessary Conference business.
- 2. Membership of the Conference shall consist of an equal number of active clergy and laity, representing each pastoral charge within the Conference. In addition to ordained deacons and elders under appointment, active clergy shall include transitional licensed local pastors and senior clergy as per the provisions outlined in 2.3 below.

GUIDELINES Continued

SECTION TWO, continued

- **3.** Following the provisions of ¶416, clergy who have taken senior status shall retain their right to both voice and vote within the Conference if they fulfill either of the following conditions: (a) they are within seven years of the effective date of their aligning with the Global Methodist Church or the end of their last appointment, or (b) they are under appointment by the Conference for at least one-quarter time. Senior clergy not qualifying under the preceding retain voice, but not vote, at the annual conference, and they will not be counted for balancing purposes between clergy and lay delegates.
- 4. Conference sessions shall generally be conducted using *Roberts Rules of Order*, though whenever possible, the Conference shall attempt to conduct its business by consensus vote. The Conference may also choose to limit debate and speeches in favor or in opposition to a motion at the discretion of the President or chair.
- 5. These Conference guidelines may be suspended by a two-thirds majority of those present and voting.

SECTION THREE: FINANCIAL PROCEDURES

- 1. The Finance and Administration Committee shall annually prepare and recommend a Conference budget for the next calendar year.
- 2. Individual congregations shall calculate their share of the Connectional Funding for both the Conference and the denomination as a whole as per ¶349.3 by January 30 of each calendar year based on the prior year's local church operating income. The congregation's share shall be no more than 1.5% for the general church, and no more than 5% for the annual conference.

Ministry Meeting Minutes, Continued

Jason Burnham:

Would you like to vote on the nomination slate? All right, all those in favor, would you say aye? It is affirmed and we will proceed with the Pro Tem Report.

Jim Welch:

President Pro-Tem Address

I've asked Vivian and Jason to stand up with me during this Pro Tem report because we are indeed a team that works together. It's been less than a year that we've been doing this and here we are in our second Conference - past the 1st Annual Conference, past the Convening Conference - gathered together with over what 1200 people here in worship and representing churches from three different states, three different Annual Conferences that have come together to form the Eastern Texas Conference. Our collaboration together, Jason and Vivian, means that during this Pro-tem report, it will be given by all of us. Mary Oliver has a compilation of poetry called <u>Devotions.</u> I want to share with you a poem, up first, called <u>Storage</u>. You'll see a picture to the right. I hesitate to tell you that— that's my garage. And I also tell you it's only part of my garage. Not all of it. I'd like to say that my spiritual life is more organized and less cluttered than that, but sometimes the Lord corrects me and clears that out too. But that's kind of what our lives look like, is it not, occasionally?

Mary Oliver's poem, <u>Storage</u>. One of the things that strikes me about our life together in the Global Methodist Church is that we have been in the business over the past months, discarding things. Getting rid of things that divert our attention from a primary focus to which we are called. That primary focus is on Jesus, who calls us to worship with passion as we did last night and this morning. It calls us to a bold witness. And to service rooted in an extravagant love, with which we ourselves offer love. We are called today by Christ, to allow the Holy Spirit to burn away that which clutters our spiritual lives. And to allow a focus on that, which is essential, that we are called to by our Lord. I pray we will continue to burn away those things that are on unimportant and focus on that which gathers us together with such passion and commitment, a devotion to Jesus, and to the Lord's Kingdom.

Jason Burnham: Boynton Methodist Church's story. Wheelock Methodist Church's story.

Vivian Kinnear:

We are called to tell bold stories. Six months ago - 245 churches. In Texas - 235 had joined the Eastern Texas Conference. In Louisiana, ten (10). In six months, Texas add-ed twenty-six (26) more churches. The churches in Louisiana more than doubled, with twenty-two (22) joining. Arkansas decided they wanted to join us and brought, to-date, forty-six (46) more churches. In six months, God increased our Eastern Texas Conference connection by 38%. We boldly stand today at 339 churches. More churches, especially in Arkansas and Louisiana, are in the process of discerning where God is calling them to connect.

Drew Essen:

Conference's Strategic Planning Team Report, Page 33, Pre-Conference Journal Last November, Jim and Jason called together and commissioned the Strategic Planning Team of the Conference charged at examining how we were to approach this vision. How would we begin to give language to this vision? How would we begin to define that vision? We sent out over 2000 surveys, had over thirty-one (31) one-on-one interviews. Asked these questions - What do we want this conference to look like? Where do we feel like the Holy Spirit is leading us? How do we begin to capture the energy that the Spirit is moving among us and how do we bring it all together? From our surveys and interviews, we heard that we wanted to be a Christ-centered, lay-led, truly global church made-up of every tribe, every tongue and every nation. We heard that we want to return to our deep Wesleyan roots of intentional discipleship and risk-taking evangelism. We heard that we wanted to be a Conference that raises up the next generation of Methodist leaders, both clergy and lay. We heard there was a desire to return decision making abilities and powers to the local congregations and leaders that make up our Conference. And finally, we heard overwhelmingly from you, that we wanted to invest our time, our talent and our treasure, into a broken world that so desperately needs the love and grace of Jesus Christ. So, in this initial report we wanted to present guidelines rather than goals as we build towards our shared future together. We wanted to capture and affirm our mindset before we pursued a model. In our study, we heard that defining the roles was important, defining the roles between members and churches and the Conference was an essential step that we needed to take to gain clarity in who we are together. So, this led to our strategic framework. The framework is threefold and very simple, as we talked about this morning. It's threefold, and it focuses on scripturally and practically defining the roles within our Conference. Member's disciple. The first tenant of our strategic framework together is that Members disciple. (VIDEO: The Stories We Tell: Buck Thronton, Winnie). The second tenant of our framework is that churches multiply. The Conference's job is to equip. So, in review: members disciple; churches multiply; and the Conference equips.

John Wayne McMann:

Class Meetings Report, Page 68, Pre-Conference Journal For too long in our Methodist connection, discipleship has become a category that encapsulates spiritual formation, education, and program ministry, with very few defining characteristics or Wesleyan distinctives.

Zach Anderson:

What is a disciple? What is discipleship? And specifically, what is discipleship to Jesus Christ? Discipleship to Jesus is a way of living. It's a holistic pursuit of a relationship with a person. A 2-way, give-and-take relationship with the person. That person is Jesus. And this relationship is made possible by the power of the Holy Spirit. This way of life, this relationship undergirds all aspects of your life, and as such, discipleship will look different in different contexts. However, discipleship and the life of the disciple will always be guided by three underlying principles. The life of a disciple is devotional, transformational, missional. A class meeting is a transformational small group of people who meet weekly to give testimony to their life in God and encourage one another in the pursuit of becoming more like Jesus. Or a simple definition I like to use is a support group for sinners.

Roger Clayton:

The majority of people in our Conference do actually know what the class meeting really is. Which means the seminaries worked. 89% of our responses said that they knew what the class meeting was. But the data also showed us that many either didn't see or didn't believe that the class meeting was something that could work in 2023, as it did so long ago with John Wesley and the originators of the Methodist movement. With only 34% of responders claiming that they had a meeting that matched that description of the class meeting within their congregations.

Rhonda Bourgeois:

Class Meetings provide an opportunity for believers to actively pursue becoming more like Christ. These Wesleyan style groups help participants move from simply consuming information to pursuing transformation and building community, spiritual community. <u>VIDEO: The Stories We Tell: Marvin Methodist Class Meeting</u>

Marc Donaldson:

The Eastern Texas Conference Class Meeting Team will be a catalyst for the implementation of Wesleyan accountability structures across the Conference for the transformation of local congregation. With testimony, training and continuing education, we will equip pastors and congregations to begin class meetings where local members will learn to walk with one another on their journey of faith. This will be accomplished by: #1. Boldly witnessing and giving testimony as often as possible to the power of accountability within congregations to the whole of the Eastern Texas Conference. #2. Offering tangible training to build up both clergy and lay leaders who are well versed in accountability groups in order for them to implement accountability groups within their local setting. #3. Provide ongoing support and resources to the local congregation and the local pastor, no matter where they are in the process of implementation. November 12th -class meeting webinar, main presenter Doctor Kevin Watson.

Guy Williams:

NexGen Ministries Report, Page 65, Pre-Conference Journal Our team's work is to support churches as we share the Gospel and pass on the faith once delivered to the Saints, to the next generation.

Russell Martin:

Many churches are looking for qualified individuals to step into youth and children's ministries as staff and volunteers. NexGen Ministries is answering the call to equip those leaders in three different ways. First, our NexGen Summit will be held at Livingston Methodist Church August 5th from 10:00 till 2:00. Secondly, offering a youth ministry and Children's Ministry certification through the School of Ministry. And finally, we need a network of workers, pastors and volunteers to share ideas, pray for one another and be in connection. Raising up the next generation of leaders means providing opportunities to serve at local churches alongside our pastors and the great lay people of our conference as ministry interns. We are developing a summer ministry internship program for next summer that will give young people hands-on experience and mentorship so they may discern God's call for their life. We are offering a marriage ministry training and seminar retreat.

Our Conference will put on a summer camp at Lakeview in June 2024.



Jon Thornsbury: International Ministries Report, Page 64, Pre-Conference Journal

African American Hispanic Initiatives Report

We do bring our gifts and graces to the church. We ask for the resourcing and the support of the church in the work we are called to do in the life of the church. We ask you to walk with us and journey with us. We are one people, one tribe called together to be who God has called us to be. We ask you to double down with us and understand that we're a church that should look like the body of Christ.

Arturo Cadar:

Greetings and expressions of gratitude from all twenty-two (22) Hispanic pastors of the Eastern Texas Conference, including two (2) Hispanic pastors, one (1) each from Louisiana and Arkansas, and three (3) who will be ordained tomorrow. Retells story: Resurrection Global Methodist Church in Katy.

Jason Smith:

Our church started January 8th with 310 people present on our first Sunday at Katie High School. That next Sunday, February 5th, we all met together in the Katy High School Auditorium with Jim Welch by my side, and we welcomed 335 new members to the church. God's been placing on my heart, we are going to have a Hispanic Ministry. And so, of course, I thought in 5 to 10 years, we're going to have a Hispanic ministry in our church. So, the week after we met here in February, Artie called. Daniel and I just started dreaming right there at lunch. Churches have done this wrong for so many years. We adopt these communities into our churches and then we give them the 1:30 slot, later in the day. And they're not a part of the life of the church. They are of the church if they're not contributing enough to pay for their ministries.

That is the wrong way to look at ministries in our churches. And I sat down across from him, and I said, and I slid this piece of paper across. And on it, it said 'one (1) name, one (1) Church, two (2) languages.' And Daniel nodded, stood up, and we hugged.

Daniel Hernandez:

We are very grateful for this opportunity to share with all of you our experience that not only like a pastor, like a family, like our team leaders and all congregation feel welcoming when we meet with the other congregation. And the second lunch, the second meeting started. So yes, you see we are ready. When? Where? When do you want to join us? I'm like what? Yes, you want to join right now? Come to meet my congregation, with my leaders. And then I'm going to talk to my congregation and my congregation says When? Right now. Okay, I'm going to get it. That accelerates the time and then when we meet together, we enjoy the Anglo congregation. Some only speak in Spanish. Hispanic congregation we have only a little bilingual people and then when they meet, wow. Incredible. They cook. They smile. It was incredible, incredible, incredible. And then we start working together. We feel welcoming.

Arturo Cadar:

Beginning this year, we're going to invest a considerable amount of resources in recruiting and developing Hispanic clergy and lay leaders to programs such as the MDiv program at United Theological Seminary, which is totally offered in Spanish and online, and the Asbury's Latino Center certificate in Theological Studies, also offered in both bilingual and Spanish-only formats.

John Campbell New Church Plants

Our mission: the New Church Starts Team is tasked with equipping local clergy and laity to form into new GMC communities. We aim to share the valuable resources of this Conference with the new starts through prayer, grants, planning advice and shared knowledge. There are considerations about legal, finance, facilities, communication, marketing, pastors and prayer. No two (2) church starts will be the same but many of these processes are and we share that. We are also calling on the Conference to offer some financial assistance through grants to new churches. Within the budget presented to you, and you will vote on later today, you will see a \$200,000 line item for new church starts. That's roughly 12% of our Conference budget.

Grants can be used for a wide variety of startup costs. We won't be buying large tracts of land with this, but we can help churches get started. The Woodlands Methodist Church has committed to planting new churches and are underway in developing online training modules to equip pastors and laity for planting. It is funded, it is staffed, and it aligns with the goals of our committee. In February, we welcomed the seven new churches.





Finance and Administration Report, Pages 35-51, Pre-Conference Journal

On August 26th of 2022, we were legally Incorporated in the state of Texas. Now we are a Conference of 339 churches with the expectation of even more coming. We have churches all over Eastern Texas, Louisiana and Arkansas. We have 17 new church starts that are in some form of development. All of this has been accomplished with minimal paid staff, many of whom have been paid well below a market or even a fair wage, and the efforts of laity and clergy working virtual second job as volunteers. I'm here to tell you we are financially strong.

Our Balance Sheet has a liability of \$100,000 dollars that's listed as prepaid receipts. This is the generous gift given to our Conference at the beginning of 2023, by The Woodlands Methodist Church. As per our agreement with them, effective July 1, this item moved from a liability to an income item, and it represents The Woodlands Methodist Church annual commitment to Conference Connectional giving. June 30th, we had cash in the bank of just over \$380,000 dollars and zero (\$0) long term liabilities. The only liabilities that we have relate to payroll and they're there simply because they are timing issues. On page 38, you will find our Income Statement. And see that through 2023 we have total revenue of just over \$463,000 dollars

FINANCE & ADMINISTRATION REPORT

By Mike Tyson

Your Finance and Administration Committee (FAC) has been hard at work to responsibly steward the financial resources of our growing Conference.

Through June of 2023 we have total revenue of \$463,305 this compares to budgeted revenue for the year of \$750,000. We are tracking nicely toward that budgeted number. Through June we have an excess of income over expenses of \$234,064. You will notice on our balance sheet that we have a liability of \$100,000 listed as "prepaid receipts" this is the generous gift given to our Conference at the beginning of 2023, by the Woodlands Methodist Church (TWMC). As per our agreement with them, effective July 1 this moved from a liability to an income item and represents TWMC annual commitment to Conference Connectional giving. Thank you TWMC for your generosity and for now being a part of ETXGMC!

Your FAC is recommending that several financial policies and procedures for the Conference be approved. Those policies have been created by a subgroup of the FAC committee, reviewed by your Conference staff and approved by the FAC. These policies were then subsequently reviewed and approved by the Conference Connectional Council. They are a part of this report for your approval.

The Connectional Council is recommending that we institute a cap on Connectional Giving to the Annual Conference. The FAC and the Connectional Council are recommending that we approve a cap, so that no church in the Annual Conference contributes more than 25% of the Annual Conference's total income. See the examples below. The rationale behind this is that the ETXGMC does not become overly dependent on the funding from a single church.

Example:

Total Income for the Conference is \$1,000,000 the 25% cap is \$250,000.

Conference Connectional Funding percentage is 1.75%

Church A's operating income is 15,000,000.

The Connectional funding obligation would be 262,500.

Therefore, church A's Connectional Funding obligation would be \$250,000.

It is the goal of the FAC to keep the Connectional Funding request from the Annual Conference as low as possible. Throughout 2023 we have maintained our Conference Connectional Funding at 1% of a church's operating income. Moving into 2024 we anticipate adding some additional staff, and we as a Conference are trying to move towards supporting the church's of ETX, as well as partnering with an international GMC Conference. We are still exploring how and with whom we will partner,

but we are committing \$110,000 to this partnership. We are planning to partner with various New Church starts around the Conference for \$200,000, with a max of \$50,000 to any one church. Further, are committing to our Hispanic and African American initiatives \$150,00 to help grow healthy leadership and prospering churches in these important areas of the ETXGMC.

As all pension and benefits are being handled at the denominational level we are not required at this time, to staff for any of the administrative positions to handle the details of those pensions and benefits. Your FAC and Connectional Council are committed to keeping the Conference as lean as possible and still do an excellent job of supporting the churches of the ETX. We remain leery of creating any kind of bureaucratic system that might sap the resources and vitality of our local churches.

You will see as part of our budget for 2024 that we are requesting that the Conference approve a Conference Connectional Funding rate of 1.75%. This is a three-quarter percent increase over our current one percent rate. This will allow us to make the investments in our local and international GMC churches that we believe will serve the Kingdom of God. This rate will also allow for adequate funding of Conference Staff. This 1.75% compares to 3% in the Mid-Tex Conference and 5% in the Great Plains Conference (our sister Conference sin Texas).

You will also find as an addendum to the 2023-2024 budget that is a part of this report the staffing costs for the Annual Conference, we lift this up to you to be as transparent as possible. You will see that there is a category called Future Staff Development. That is there to accommodate the future needs of the Conference. All hiring of Conference staff will be vetted and recommended by a Conference Personnel Committee and all director/ office level staff will be approved by the Connectional Council. With the unanimous support of the Finance Committee and the Connectional Council we present the 2024 budget as printed.

What an amazing year 2023 has been for all of us! We began this journey as a Conference with zero churches and \$4,852 dollars in the bank. At the beginning of this year, we were recognized as an Annual Conference of the Global Methodist Church. We are now a Conference of 338 churches covering the states of Louisiana, Arkansas, and the Eastern part of Texas. God is moving among us and doing amazing things for the Kingdom of God in our communities and the world. As Paul says in Romans 8:31 "If God is for us, who can be against us?"

Through June, we have an excess of income over expenses of right at \$234,000 dollars. These excess funds would be used to build up a modest reserve for ongoing Conference expenses. Your Finance and Administration Committee is recommending that several financial policies and procedures for the conference be approved.

PAYROLL PROCESS

Recording, Safeguarding, and Accounting for Payroll Disbursements

Focus on Internal Accounting Controls:

- Safeguarding and detecting unauthorized cash payroll transactions
- Appropriate authorization and control over the creation of a paid employee
- Proper recording of payroll disbursements in the payroll accounting system
- Accurate reporting of year-end federal tax documents including Forms W-2 and 1099 and related summary reports to be filed with the Internal Revenue Service

Accounting Procedures for Payroll Disbursements

- 1. The COO is responsible for the establishment of an arrangement of a relation ship with an automated payroll processing service. Such arrangements will be reviewed on an annual basis.
- 2. Payroll distributions are made by electronic deposit where at all possible. Payroll distributions are made on the 15th and 30th of each month.
- 3. The CAA will enter all payroll information including hours worked by employees paid by the hour. This responsibility falls to the Treasurer when the CAA is unavailable.
- 4. The CAA is responsible for the maintenance of the employee database including the setting up of new employees. Control should be established over this area to ensure that fictitious employees are not established.
- 5. The CAA is responsible for the timely completion and filing of Forms W-2 for all employees and pastors and 1099 for applicable vendors and independent contractors under the direction of the Treasurer.

6. The Treasurer will be responsible for the Conference's compliance with all tax filings.

ACCOUNTING AND FINANCIAL REPORTING

Recording, Classifying and Reporting Financial Results

Focus on Internal Accounting Controls:

- Safeguarding and detecting of unauthorized entries to the financial accounting and reporting process.
- Timing reporting and comparison of actual to budgeted revenues and expenses.

General Ledger Maintenance and Journal Entry Process

- 1. Journal entries are to be made by the Treasurer.
- 2. Entries to the financial records are to be made only for transactions that cannot be made through established processes, i.e., cash receipts, cash disbursements, and payroll.
- 3. All entries are to be posted into the QuickBooks System and hard copies are printed out and signed along with supporting documentation attached.

Capitalization Limits

1. Expenditures in excess of \$10,000 that benefit more than one fiscal period are to be capitalized.

Financial Reporting

The Conference's financial reporting will be based upon the cash basis of accounting modified to reflect Finance Committee designated and or donor-restricted funds.

The Duties and Responsibilities of the Finance Committee

- 1. The approval of the annual budget is to be submitted to and approved by the Finance Committee prior to the budget's submission to the Annual Conference for final approval.
- 2. The establishment of written financial policies and documentation of the internal accounting controls required to protect the financial and other resources of the Conference.
- 3. Provision for an annual audit of the Conference's financial records by a respected certified public accounting firm.
- 4. Recommendation to the Treasurer of appropriate depositories for the Conference's funds.

EXPENSE ACCOUNT POLICY FOR CONFERENCE EMPLOYEES AND VOLUNTEERS

Document created: April 20, 2023 Policy approved by FAC: July 5, 2023

The Finance and Administration Committee of the Eastern Texas Conference of the Global Methodist Church (the Conference) adopts the following resolution pursuant to IRS regulations. It is effective for the calendar year 2023 and all future years until amended or unless expressly revoked or suspended.

The Conference's employees and volunteers will be reimbursed for ordinary and necessary business expenses incurred in performing their ministry responsibilities on behalf of the Conference. Requests for reimbursement should include documentation and substantiation of the amount, business purpose, date, and place of the cost; a list of those present is also needed for meals. Appropriate documents, cash receipts, canceled checks, credit card sales slips, and contemporaneous records (for those non-receipt expenses less than \$75) must be attached to each expense report.

These reimbursements shall be estimated and included in preparing the annual Conference budget and assigned to accounts as appropriate.

The Treasurer must be provided the substantiation within sixty (60) days of the employee or volunteer incurring the expenses. If an individual is given an advance for expenses, that individual must return any amounts received in excess of the substantiated cost to the Conference within one hundred twenty (120) days of receipt of the advance.

The Conference will not report any properly substantiated reimbursement payments as income on Form W-2.

The Conference will not reimburse travel expenses for spouses, dependents, or others who are accompanying individuals conducting business for the organization unless they, too, are conducting business for the organization.

CASH DISBURSEMENT PROCESS

Recording, Safeguarding and Accounting for Cash Disbursements

Focus on Internal Accounting Controls:

- Safeguarding and detection of unauthorized cash disbursements
- Proper recording of cash disbursements in the cash disbursements/payable system
- Appropriate level of approvals to support cash disbursements
- Timely reconciliation of cash disbursements records to bank statements

Cash Disbursements Sources:

- Checks
- Debit and Credit Cards
- Other Electronic Means

Individuals Involved in Cash Disbursements Process:

- Conference Administrative Assistant (CAA)
- Conference Chief Operating Officer (COO)
- Conference Treasurer

Accounting Procedures for Cash Disbursements:

- 1. Cash Disbursements are to be supported by one or more of the following source documents:
 - a. Vendor invoices supported by appropriate approval and documentation
 - b. Check requests and appropriate supporting documentation where payments are not otherwise supported by an invoice
 - c. Staff/Pastor Business Expense Reimbursement reports and appropriate supporting documentation
 - d. The COO has the primary responsibility to code disbursements to appropriate general ledger accounts
- 2. Preparation of Checks
 - a. The CAA has the primary responsibility to initiate the preparation of checks through the QuickBooks System
 - b. Non-budgeted expenses must be approved in advance by the COO before check preparation is initiated
 - c. Check numbers are computer assigned by the QuickBooks System though manual exceptions are allowed as necessary
 - d. Blank check stock is maintained in a locked desk drawer accessible only by the CAA and the COO
 - e. Voided checks are logged separately; if possible, such are to be kept in a locked file cabinet with the signature area removed.

CASH DISBURSEMENT PROCESS, continued

- 3. Signature and Mailing
 - a. Signature authority is limited to the COO and others [dual signatures are required for disbursements in excess of \$5,000] as approved by the Finance Committee
 - b. Once signed, the CAA encloses checks into envelopes along with appropriate supporting documentation and then posts the envelopes inside the nearest post office.
- 4. The Treasurer is responsible for the creation and updating of the Chart of Accounts
- 5. Cash transactions by wire transfer are not allowed
- 6. Other Electronic Means of Payments include automatic payments for subscriptions and medical insurance drafts
- 7. Debit Card Transactions
 - a. A limited number of debit cards exist to cover petty cash transactions
 - b. Debit cards are safeguarded in a locked desk draft along with blank check stock
 - c. Documentation is required to support each transaction
 - d. Debit card usage is limited to those who are authorized in advance by the COO to use the card
 - e. Debit card usage is to be recorded in the accounting records shortly after the needed purchase has been incurred
- 8. Employee Credit Cards
 - a. The Conference provides VISA credit cards to selected employees who regularly make expenditures on behalf of the Conference
 - b. Requests for credit cards must be approved by the Treasurer or the Chair of the Finance Committee
 - c. Prior to the receipt of a conference credit card, the employee must sign an employee credit card agreement acknowledging responsibility to use such card
 - d. Assigned credit limits are to be determined by the Treasurer.
 - e. Should an employee need a temporary increase in the card limit to meet a specific need, such limit may be temporarily increased by the Treasurer upon submission of a written request by the card holder
 - f. Employees are to provide a timely accounting of credit card expenses and documentation in advance of payment by the Conference Office.
- 9. On a monthly basis, the Treasurer will reconcile the QuickBooks book balance of cash to the balance reflected on the bank statement. As a part of the reconciliation process, the Treasurer will review the following:
 - a. Sequence of QuickBooks System generated check numbers
 - b. All disbursements clearing the bank account are properly recorded in the Conference accounting records
 - c. Any checks remaining outstanding for in excess of sixty days will be researched and, if necessary, a stop payment issued and the disbursement reissued

CASH DISBURSEMENT PROCESS, continued

10. Budgeting

- a. Accounting budgets are required to be prepared annually
- b. The COO and the Chair of the Finance Committee are responsible for the preparation of the annual budget (and the monthly spreading of such annual budget)
- c. The annual budget is submitted to the Annual Conference meeting for approval after having been approved by the Connectional Conference
- d. The COO is responsible for the monitoring of variances of budget to actual expenditures on a monthly basis which are then reported to the Executive Staff

CASH RECEIPTS PROCESS

Recording, Safeguarding and Accounting for Cash Receipts

Focus on Internal Accounting Controls:

To safeguard and prevent the interception of cash receipts prior to initial recording

- Safeguarding and detecting the interception of cash receipts subsequent to initial recording
- Proper recording of cash receipts in the cash receipts system
- Safe and timely deposit of funds into approved bank accounts
- Timely reconciliation of deposit records to bank statements

Cash Receipts Sources

- Checks received through the mail
- Online receipt
- Currency and checks received from event collections

Individuals Involved in Cash Receipts Process:

- Conference Administrative Assistant (CAA)
- Conference Chief Operating Officer (COO)
- Conference Treasurer
- Event Leaders

Flow of Cash Receipts Through Accounting System:

- The CAA is responsible for opening the mail from the U.S. Postal Service or third-party delivery services. Upon receipt of checks, the CAA restrictively endorses each check using a "for deposit only" stamp and then logs individual checks into the QuickBooks "Payments to Deposit" log in batches of 10. An example of the QuickBooks Deposit Summary is available upon request.
- 2. In advance of the actual bank deposit, the CAA secures undeposited checks (and small amounts of cash) in a locked drawer in her desk. Only the CAA and the COO have access to the key unlocking the desk drawer.
- 3. Actual receipts of currency at the Eastern Texas Conference office are infrequent and de minimis in amount.

CASH RECEIPTS PROCESS, continued

- 4. Electronic cash receipts are received through:
 - a. Online transfers through the Conference bank account at Amegy Bank; or
 - b. Automated Clearing House (ACH) transfers received through Melio or other web-based cash transfer applications.
- 5. On a daily basis, the CAA downloads notifications of electronic cash receipts for the primary purpose of matching deposits to invoices and adding posted deposits to the downloaded deposits. The CAA then posts electronic deposits to the QuickBooks "Payments to Deposit" log in the same manner as actual checks to be deposited.
- 6. Receipts of currency arise primarily from conference events where offerings/sales proceeds are received. Event leader(s) is (are) responsible for collecting and safeguarding currency in tamper-proof bags. If host location is a church, their finance Department makes deposit then cuts a check to the Eastern Texas Conference upon settlement of expenses.
- 7. On a weekly basis, the CAA will prepare a deposit slip and take the deposit (in a zippered bag) to the closest **associated bank** branch. The CAA will obtain a validated deposit receipt to substantiate the amount of funds deposited such validated deposit slip to later be independently reconciled to the QuickBooks Cash Receipts Log by the Treasurer as referenced below.
- 8. On a monthly basis, the Treasurer will reconcile the QuickBooks book balance of cash to the balance reflected on the bank statement. As a part of the reconciliation process, the Treasurer will weekly reconcile deposited funds from the validated deposit slip against to the Cash Receipts Log initially prepared by the CAA and the QuickBooks Deposit Summary.

These policies have been created by a subgroup of the Finance and Administration Committee, reviewed by your Conference staff and approved by the Finance and Administration Committee. These policies were then subsequently reviewed and approved by the Conference Connectional Council. They are part of this report, and they need your approval. The Connectional Council and the Finance and Administration Committee are also recommending to the Annual Conference that we institute a cap on connectional giving to the Annual Conference. We are recommending that we approve a cap, so that no church in the Annual Conference contributes more than 25% of the Annual Conference's total income. Should be an example on the screen.

The rationale behind this is that we as a conference do not become overly dependent on the funding of a single church. We believe that this protects us. At this time, it's not anticipated that any church will fall under this cap, but this is the example. So, if our Conference income is \$1,000,000 dollars. The 25% cap would be \$250,000 dollars. If our Conference connectional giving rate is 1.75%, we use that number times your operating income that you provide to us. If church A is operating income as \$15 million dollars, their obligation would be \$262,500 dollars. Because we have this cap in place, their actual connectional giving to the Conference would be the capped amount at \$250,000 dollars. Again, we believe that this protects us as a Conference from becoming dependent on any one church.

It is the goal of the Finance and Administration Committee to keep the connectional funding request from the Annual Conference as low as possible. Throughout 2023, we have maintained our Conference connectional funding at 1% of a churches operating income. Moving into 2024, we anticipate adding some additional staff and we, as a Conference, are trying to move towards supporting the churches of the Eastern Texas Conference by equipping now as well as partnering with an international Global Methodist Church Conference. We're still exploring how and with whom we will partner. We are committing \$110,000 dollars in 2024 to this partnership. We are planning to partner with various new church starts around the Conference for a total of \$200,000 dollars in 2024, with no one (1) church receiving more than \$50,000 dollars. Further, we are committing to our Hispanic and Black Initiatives, a total between the two (2) of \$150,000 dollars to help grow healthy leadership and prospering churches in these important these vital areas of the Eastern Texas Conference. As all pension and benefits are being handled at the Denominational level, we are not required currently to staff for any of the administrative positions to handle the details of those pensions and benefits. Your Finance and Administration Committee and your Connectional Council are committed to keeping the Conference as lean as possible and yet still do an excellent job supporting each of you in your churches and in your ministries. We remain leery of creating any kind of bureaucracy, any kind of bureaucratic system that might sap the resources and vitality of our local churches. You will see as a part of our budget for 2024, we are requesting that the Conference approve a Conference Connectional Funding Rate of 1.75%.

You will see that highlighted in blue on page 36 to indicate that that is an action item for the Annual Conference. *(included on next page)*.

This is a three-quarter (3/4%) percent increase over our current one percent (1%) rate. This will allow us to make the investments in our local and international churches, that we believe will serve the Kingdom of God. This rate will also allow for adequate funding for Conference staff. This one-point-seven-five (1.75%) compares to five percent (5%) in the Mid Tex Conference and three percent (3%) in the West Plains Conference, our sister conferences in Texas.

You also find an addendum for the 2023-2024 budget on page 51 in the Conference Journal.

2023 EASTERN TEXAS CONFERENCE STRATEGIC PLANNING REPORT

In November of 2022, the Strategic Planning Team was formed at the direction of President Pro Tempore Jim Welch and Executive Officer Jason Burnham as the Eastern Texas Conference began to take a more defined shape. Rev. Welch, Rev. Burnham, and the Connectional Council were already beginning to cast a compelling vision for our Conference's exciting, Spirit-filled, lay-led future, and we were charged with examining our Conference framework to determine how we could begin to define and achieve that vision. We assembled an incredible team of lay and clergy leaders from different backgrounds, church sizes, and locations and began to discern where the Holy Spirit was calling us.

As a first step of this discernment, we wanted to gather feedback from as many people as possible. The team sent over 2000 surveys to conference members and held 30+ one-on-one interviews, including with our Bishops and denominational leadership. The feedback we received was constructive, highly encouraging, and made us more excited than ever to be a part of the work God is doing in the Eastern Texas Conference of the Global Methodist Church.

From our surveys and interviews, we heard that we wanted to be a Christ-centered, lay-empowered, truly Global Church made up of every tribe, tongue, and nation. We heard that we want to return to our deep Wesleyan roots of intentional discipleship and risk-taking evangelism. We heard that we wanted to be a conference that raises the next generation of Methodist leaders, both clergy and lay. We heard that there was a desire to return decision-making abilities to the local congregations and leaders that make up our conference. Finally, we heard overwhelmingly from you that we wanted to invest our time, talent, and treasure to witness a broken world that so desperately needs the love and grace of Jesus Christ. The good news is that this is not only an aspirational goal, but something already happening in our midst. I look forward to sharing stories with you at the conference about how our churches, of every size, shape, and make up are already living into this vision that we as a Conference are developing together.

We also heard that we need a way to organize all these efforts so that like John Wesley, we can share in a methodical and strategic way to make disciples of Jesus Christ who worship passionately, love extravagantly, and witness boldly.

This brought our team to identify and create a strategic framework that we will be seeking your approval on when we gather in College Station. This framework is not necessarily a strategic plan, but rather a way that we will be organizing our shared work together moving forward.

In our study, we heard that defining the roles of members, churches, and the Conference was an essential step in gaining clarity in our ministry, so this led to our strategic framework being as follows:

Conference equips by discovering, developing, and deploying pastoral leaders

 \cdot Conference equips by providing resources and training

 \cdot Conference equips by bringing churches together into true connectionalism

By providing simple, one-word roles for each level of our conference, we will have clarity on how each part works together to achieve our Holy Spirit guided mission and vision. This framework will be a way that our strategic aims and initiatives will be organized and provide us all a shared language as we pursue the story that God is writing for our conference.

We are excited to discover with you the application of this methodology and seek your endorsement for us to continue our work. With your endorsement and approval of this framework, our team will begin working with all of you on how we can lay out gospel centered aims and initiatives over the next year. We then plan to bring back clear and concise goals at our next gathering.

Thank you for your time and attention and praise be to God for our shared work in this new Methodist movement. We look forward to being with you all soon in College Station.

Bishop Jones:

If you will approve this Strategic Planning Team Report and Strategic Framework, would you say 'Yes'? Any opposed, 'No'? (none). And it's approved.

Bishop Jones:

Episcopal Address:

"I started praying for renewal years ago. I'm Bishop of thirteen (13) Annual Conferences." Bishop Jones shared accounts of a church in the Philippines which meets in a movie theater and had thirteen (13) certificates of conversion; of the Mid-Texas youth camp, Revive, with 410 young people attending. From these 410 youth, there were 70 professions of faith and 28 came forward as feeling called to full-time ministry. "I have known lots of people who used to go to youth meeting and gave their life to Christ. I teach at Truitt on Wesleyan History, Transformational Discipleship Systems. I know pastors for three (3) small churches in the Waco area. Churches with bands - with ages between 16-90. Transforming people into real Christianity, engaged in all ministries, fully committed to modeling ministry. John Wesley was afraid we would lack power but have form noted our job is to recommit to what Methodist was at it's very best. I started at age 15, in 1970, and think what's happened in that time." Bishop Jones suggested the one of the biggest distractions was a mission statement, where we found lots of other ways to disperse time, talents and money. "The main thing is to keep the main thing the main thing – To make disciples... It starts with you all in your local churches. We are going to continue to call you to keep the main thing the main thing. As Bishop, how joyful I am to be serving alongside you."

Jason Burnham:

Thank you expressed to Methodist Children's Home for providing our lunch. Welcome expressed to Trey Oakley, President and CEO" MCH is a resource for churches, with Houston and Tyler offices.

Jason Burnham:

Breaking news: this was the only church large enough to hold Conference. Now we have three (3) churches large enough. Our next Annual Conference will be June 19-22, 2024, in First Methodist Church in Shreveport, LA. Thank you, Christ Church, for hosting us twice. Prayer offered by Jason Burnham, before dismissing for lunch.
